Private Mortgage Insurance (PMI) Cancellation Requirements	1	You, as a mortgagor on the loan, must request to remove the PMI in writing. You must have made 12 or more full payments.
	2	You must be current on your payments. You are considered current if the payment due for the month preceding your cancellation request and all outstanding late charges have been paid.
	3	You must have a good payment history. This is reviewed by the following standards: <ol style="list-style-type: none"> 1) You have not made a payment that was 30 days or more past due within the 12 months prior to the cancellation date. 2) You have not made a payment that was 60 days or more past due within the last 24 months prior to the cancellation date.
	4	You must certify that the equity your property is not subject to a subordinate lien.
	5	Your loan must meet the principal balance to property value ratio (LTV) requirements. This is reviewed by the following standards. <ol style="list-style-type: none"> 1) Principal Balance of your mortgage has reached 80% of the Original Value of your home. 2) Principal Balance of your mortgage has reached 80% of the Current Appraised Value of your home. <i>There will be a non-refundable appraisal fee that must be paid prior to the ordering of the appraisal</i> <p>*Automatic Termination occurs when your mortgage has reached 78% of the original value of the home. On that date, payments must be current. If you are NOT current, the PMI termination will occur on the 1st day of the 1st month following the date that you become current.</p> <p>*Final Termination occurs when you reach the mid-point of your loan's original amortization. (78%) The midpoint of the amortization period is halfway through the period between the 1st day of the amortization period established at consummation and ending when the mortgage is scheduled to be amortized.</p>
